# **Chamber Kicks Off CareerConnect Martin**

Led by the Stuart/Martin County Chamber of Commerce, CareerConnect Martin offers unemployed and underemployed individuals paid positions with great local companies, professional coaching, and onthe-job training.

Such positions—called Trial Employment Opportunities—are available across multiple industry sectors, including construction trades, manufacturing, logistics and distribution, marine, health care, agriculture, automotive and transportation, information technology and many others.

In addition to receiving support with employee recruitment, creating in-house training programs, and retention, participating businesses have salary and other related expenses covered during the Trial Employment period—mitigating some of the costs of hiring and training someone new.

Timing is ideal. According to the United Way, 44% of families in Martin County are part of the population identified as Asset Limited, Income Constrained, Employed (ALICE). Many found their economic fates made far less stable during the pandemic.

CareerConnect Martin is collaborative,

working with the Martin County Council of Chambers, Economic Council and Business Development Board of Martin County as well as various social service agencies to ensure success for trial employees.

"CareerConnect Martin allows us to embrace the individual goals of a career-seeker," says Angela Hoffman, the Stuart/ Martin County Chamber's director of workforce development. "This helps them overcome barriers such as cost of child-care, lack of transportation and access to paid training. Too often, working families are one flat tire away from crisis, and the pandemic only made their savings smaller and debt load larger," she adds. "Even with a low unemployment rate (3.1 percent) in the county, we know there are several thousand residents who are not earning enough money to sustain their families."

Employers eager to participate as a Trial Employment Site can apply now. Career-seekers can also apply now for paid Trial Employment Opportunities. 




