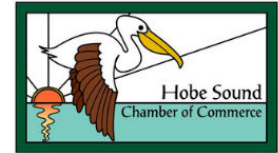

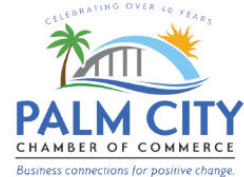

Since his return to Martin County as an Airport Operations Supervisor, Andrew earned the Certified Member (C.M.) designation of the American Association of Airport Executives and is working on his thesis for the highly coveted Accredited Airport Executive (A.A.E) designation.
