**Legislative Conference Celebrates 30 Years**

The Treasure/Research Coast Chambers of Commerce are preparing for their annual trek to Tallahassee March 19-21, 2019. It will be the 30th year for the conference, which includes the Indian River, St. Lucie and Stuart/Martin County Chambers of Commerce. This year the Stuart Chamber is coordinating the event.

The conference is hosted by the Aloft Hotel, which will include a welcome cocktail reception following arrival on Tuesday and a breakfast Wednesday morning, with Dana Young, CEO of Visit Florida as the speaker. The day will feature time with our Legislative Delegation and other invited legislators, as well as a cocktail reception hosted by The Governors Club. Wrap up is Thursday with a breakfast featuring Governor DeSantis as the invited speaker. The remainder of the day is open for individual meetings of your choice.

Each chamber prepares a "Legislative Agenda" listing their priorities for the session. Each agenda is presented to our Legislative Delegation and other legislators involved in the process of enacting laws affecting our area. In many instances all chambers lobby for our entire area. A case in point is funding for Indian River State College's request for funding a "trade school" in Ft. Pierce, another would be the septic to sewer conversion and other water quality issues.
