- 30 participants will be accepted for each LEADERship program year.
- If you are not selected to participate in this LEADERship Martin County series, you are invited to resubmit an application at a future date.
- Applications must be received by June 27, 2025. Selected applicants will be notified by July 25, 2025.

TUITION

- For Stuart/Martin County Chamber of Commerce members (either you or your employer), tuition is \$1,795.00 per participant. Non Chamber Member tuition is \$2,395.00.
- Tuition is due August 8, 2025.
- Tuition covers the cost of meals, transportation, retreat and graduation for the ten-month sessions.
- The tuition may be tax deductible as a business expense; consult your tax advisor.
